

Amended Notice of Joint Public Hearing

The Proposed Grade Reconfiguration of Success Academy Charter School – Bed Stuy 1 (84K367) in Building K033 Beginning in the 2022-2023 School Year

NOTE: This notice has been amended to provide the updated format of the Joint Public Hearing for this proposal. Due to the temporary extension of the Governor's Executive Order concerning Open Meetings Law, the Joint Public Hearing for this proposal will be held via teleconference on Monday, April 11, 2022. Details about accessing this Joint Public Hearing are below. No changes have been made to the original Educational Impact Statement (EIS) and Building Utilization Plan (BUP) for this proposal, posted by the New York City Department of Education (NYCDOE) on March 4, 2022.

A Joint Public Hearing will be held to provide the public with an opportunity to present comments or concerns on the proposal. The hearing will be held as follows:

The Joint Public Hearing will provide opportunities to learn more about potential changes to building K033.

On March 4, 2022, the New York City Department of Education (NYCDOE) posted a proposal to reconfigure the grades served by Success Academy Charter School – Bed Stuy 1 (84K367), referred to as SA – Bed Stuy 1, in building K033 from grades kindergarten (K) through 8 to grades 5 through 12 at scale, beginning in the 2022-2023 school year. SA – Bed Stuy 1 is an existing charter school currently serving students in grades K-8 in K033. K033 is located at 70 Tompkins Avenue, Brooklyn, NY 11206 in Community School District 14, referred to as District 14. SA – Bed Stuy 1 is co-located in K033 with one site of a District 75 school, P.S. K368 (75K368), referred to as P368K@K033, serving students in grades 6-8 in K033.

A co-location means that two or more school organizations are located in the same building and may share common spaces, such as auditoriums, gymnasiums, and cafeterias.

If this proposal is approved by the Panel for Educational Policy (PEP), the grades served by $SA-Bed\ Stuy\ 1$ in K033 will be reconfigured such that it will cease serving students in grades K-4 and will begin serving high school students in the 2022-2023 school year and beyond. $SA-Bed\ Stuy\ 1$ will continue serving students in grades 5-8 and will phase in one high school grade per year beginning in 2022-2023, such that it will serve students in grades 5-9 in the 2022-2023 school year, grades 5-10 in the 2023-2024 school year, grades 5-11 in the 2024-2025 school year, and grades 5-12 in the 2025-2026 school year and beyond. Grades 9-12 of $SA-Bed\ Stuy\ 1$ may also be referred to as Success Academy High School of the Liberal Arts -Brooklyn (HSLA-Brooklyn).
